Flambeau Engineering Report: Tiffiney Kleczewski – see attached handout of overview of report – there will be more detail in the report that will be coming out in the next week or so.

Healthy Lakes Initiative (fish sticks): Jeff Scheier – "Fish sticks" are a group of trees, an individual tree would be a "tree drop". Permitting is the same; it's a 3-year permit with extensions up to 2 years. Permit fee is \$300.00; we would need one for each lake. Our lake individuals cannot apply for a grant, only our Association. Costs 75% State, 25% grant recipient. The Association would have to adopt the Healthy Lakes Initiative Plan. Applications must be put in by Feb 1<sup>st</sup>. We would need one permit for each lake, but all four lakes can go on one grant. You can find information on the dnr.wi.gov website, search waterways and wetlands, then fish and wildlife habit projects, general permits, then fish sticks.
